## **Silver Predator Appoints Chief Financial Officer**

**Reno, Nevada, Sept 19<sup>th</sup>, 2014: Silver Predator Corp. (TSX.V:SPD)** (the “Company”) announces effective September 15, 2014, Mr. Timothy P. Leybold will replace Mr. Anthony Jackson as Chief Financial Officer.

### **Timothy P. Leybold**

Mr. Leybold is a seasoned financial executive with over 20 years' experience, presently serving as Chief Financial Officer of Till Capital Ltd. He was previously CFO for Gold Canyon Mining & Construction in Reno, Nevada and ICO Global Communications; a NASDAQ listed company, and Port Blakely Companies; a natural resources and land development company; as well as CFO for Coast Crane Company, Port Townsend Paper Corp. and RLC Industries, Inc.

Mr. Leybold graduated maxima cum laud from the University of Portland before beginning his career as a CPA practicing public accounting for eight years with an international audit firm. He earned his MBA from the University of Oregon in 1996. Mr. Leybold is a member of Financial Executives International and the American Society of CPAs.

### **Silver Predator Corp.**

Silver Predator's corporate mandate is to advance its Springer Tungsten Mine and Mill Complex in Nevada to production through a joint venture arrangement. A PEA completed on current resources of 355,000 Indicated tons at an average grade of 0.537% containing 190,635 STU's of WO<sub>3</sub> and 1,933,600 Inferred tons at an average grade of 0.493% containing 952,326 STU's of WO<sub>3</sub> indicates an IRR of 47% after tax with an estimated capex of 29.8 million dollars<sup>(1)</sup>. The Springer facility was originally constructed and operated by General Electric Corp. in the late 1970's and early 1980's when the project was put on care and maintenance due to low tungsten prices. The mill was modernized by Golden Predator Corp. in 2007-2008. The facility could be production capable within 12 months of a capital commitment. Approximately \$100 million dollars has cumulatively been invested by all companies in the construction and modernization of the mine and mill.

The Company also holds the Taylor silver-gold project in Nevada. The Taylor project hosts a current

resource estimate<sup>(2)</sup>, is open to expansion, and is located in a district that has identified the potential for discovery of additional silver and gold deposits.

Mr. Mike Maslowski, CPG, a Qualified Person as defined by National Instrument 43-101 and a consultant for the Company, has reviewed, verified and approved disclosure of the technical information contained in this news release.
